

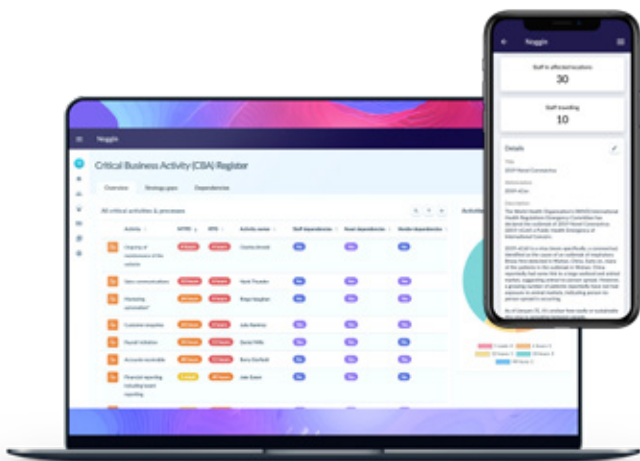

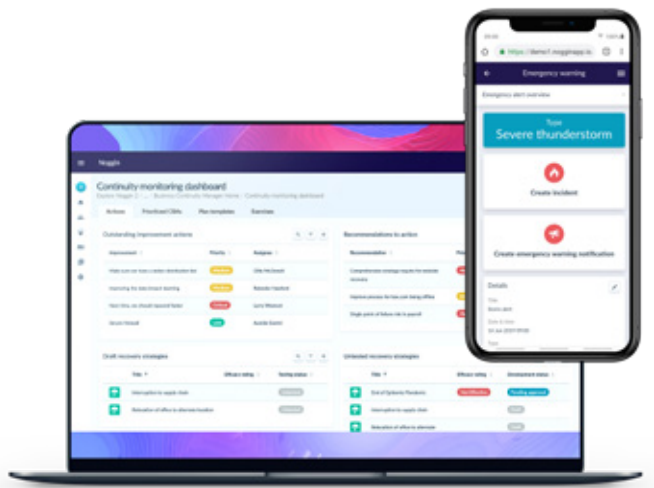
Use Noggin Business Continuity to:

- Utilising business impact analysis (BIA) & risk assessments to visualise and report on gaps in response process or areas for continual improvement

- Digitise business continuity, crisis and incident response plans, including strategies and considerations, roles and responsibilities, and pre-assigned checklists ready to deploy when incidents occur
- Running procedural reviews to ensure optimal functionality of recovery strategies and coverage of prioritised activities
- Activate crisis and incident management teams including structures, roles, capabilities required and on-call resources
- Record and manage incidents and response tasks, log and share updates, decisions, facts, and assumptions, and produce situation reports and briefings. Visualise locations of incidents, sites and assets using the fully integrated mapping features.
- Review procedures and implement lessons learned and improvement and corrective actions from exercises and incidents
- Communicate alerts, notifications and updates via email, SMS, voice or the Noggin app
- Manage key details of staff, contractors, customers, suppliers, regulators, and external parties
- Display key information where it is needed using flexible dashboards, analytics, and reporting that caters for all your stakeholders.
